

#### On The Grounds

#### CORAL CREEPER (BARLERIA REPENS)

Coral Creeper is a tough, exotic plant that stays green throughout the winter. Popular in Southern Florida, this vine-like plant can quickly cover bare ground or climb to about 6 feet on a tree trunk or wall. Often found sprawling on the ground under a shade tree, this evergreen plant with small rounded soft glossy leaves and salmon colored flowers looks similar to the dwarf azalea. The blooms are tubular, fairly large and appear primarily from late summer through fall. The Coral Creeper prefers being planted in partial shade and unlike the azalea, can send out new stems that become rooted on their own.

The Agents, Ms. Shelley E. Hamilton and Mr. Joel Freedman, will be holding this workshop to discuss the proposed development of the property. The following applications will be discussed:

- An Application for a Notification of Proposed Change to the previously adopted Palmer Ranch Increment XIII (The Glenridge on Palmer Ranch, Ordinance No. 98-081) Development of Regional Impact;
- An amendment to the approved rezone petition (RP 98-21, Ordinance No. 98-082) for 89 acres ± currently developed as The Glenridge on Palmer Ranch. The application will amend the zoning from RMF-1/PUD (Residential, Multi-Family, 6 units per acre/Planned Unit Development) with stipulations to RMF-1/PUD with amended stipulations in order to expand the assisted living units, to expand the skilled nursing rehabilitation, to expand the fitness center, to expand the assisted living and skilled nursing dining areas, to expand the dining and kitchen capacity in the "Kiltie Café", to provide additional parking, and to add access locations along the northern property boundary of The Glenridge facility to allow access to the existing facility for the newly acquired property to the north of the existing facility (see next application); and
- An application to rezone 19.68 acres ± located north of The Glenridge on Palmer Ranch property and approximately .13 miles east of Honore Avenue. This property will be rezoned from OUE-1 (Open Use Estate, 1 unit per 5 acres) to RSF-4 (Residential Single Family, 5.5 units per acre). This will allow the future expansion of The Glenridge to allow between 40 and 50 residential units.

This is a follow-up to a previously held Neighborhood Workshop, originally held on May 15, 2018. The nine-month time frame between the workshop and the required Planning Commission meeting could not be adhered to because of scheduling, necessitating this second Neighborhood Workshop. Nothing has changed from the previous workshop, as outlined above.

The aerial, and "draft" development concept plan, enclosed, demonstrates the location of both the existing facility and the proposed addition.

The NEW workshop will be held on Thursday, February 28, 2019 at 6:00 p.m. at the Covenant Life Church at 8490 McIntosh Road; Sarasota, FL This is not a public hearing. The purpose of the meeting is to inform neighboring residents of the nature of the proposal, to discuss the concept plan and to seek comments. We look forward to seeing you there.
