MEMORIAL DAY FLAGS AT HALF STAFF FROM SUNRISE TO NOON

On Palmer Ranch, smaller US flags have been set out to mark the Memorial Day period, with the flags lowered to half-staff on **Monday, May 27th** from sunrise to noon. Memorial Day, originally called Decoration Day, was first observed on May 30, 1868, when flowers were placed on the graves of Union and Confederate soldiers at Arlington National Cemetery. It is a day of remembrance for those who have died in our nation's service.

ROYAL PALMS (ROYSTONEA OLERACEA)

The Royal Palm's standout feature is the dark green pinnate, or feather-like, fronds emerging from the bright green crownshaft. The glossy green trunk changes dramatically below the palm fronds to a smooth, light gray trunk that continues down to a budge at the roots. Remarkably, the Royal Palm which does well during tropical days and cool winter nights, not only tolerates, but seems to thrive in the inferior soil and inadequate drainage of urban environments where other trees tend to do poorly.

Notice of Public Hearing

Sarasota County Planning and Development Services Department wants you to know that a property owner near you has applied for Rezone Petition No. 18-16 to rezone approximately 19.68 acres from OUE-1 (Open Use, Estate, 1 unit/5 acres) to RSF-4 (Residential, Single-Family, 5.5 units/acre) zone district to develop 41 single-family units.

The Sarasota County Commission will hold a public hearing beginning at 9:00 a.m., or as soon thereafter as possible, on June 5, 2019, at the County Administration Center, Commission Chamber, 1660 Ringling Blvd., Sarasota, Florida.
